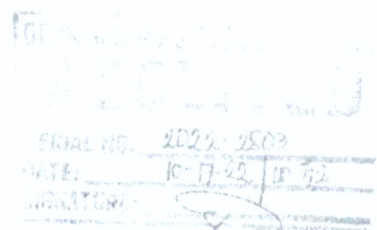

**SUBJECT :** SPOT REPORT ON THE APPREHENDED IPIL AND BINWANG LUMBER WITH A TOTAL VOLUME OF 1, 922.34 BOARD FEET AT SITIO NATUTUNGAN, BGY. QUINLOGAN, QUEZON, PALAWAN



This pertains with the apprehended 137 pieces Ipil and Binwang lumber with a total volume of 1, 922.34 board feet at Sitio Natutungan, Bgy. Quinlogan, Quezon, Palawan.

Please be informed that on October 15, 2022, at around 8:30 in the morning the team received an information from the enforcement unit of Palawan Council for Sustainable Development Staff (PCSDS) that there were undocumented Ipil lumber piled near the bodega of a certain Bonhon Bundal in So. Natutungan, Bgy. Quinlogan, Quezon, Palawan. The team immediately proceeded to the subject area and found the said lumber. It was scattered within the area and covered with some coconut leaves and it was sealed and inventoried by the team. A total of 1, 922.34 board feet of Ipil and Binwang lumber were apprehended by the joint operation of this Office, PCSDS, DMD South and MBI T4.
