Referred is the memorandum from Maximo C. Landrito, OIC Assistant Regional Director for Technical Services of MIMAROPA Region dated November 2, 2022 relative the above subject.

Per memorandum, it was noted that CENRO Puerto Princesa submitted two (2) different Seizure Receipts dated March 29, 2021 and April 14, 2021 with the estimated fair market value of 25 sacks of Almaciga Resin of Php37,500.00 and Php30,000.00 respectively. The Toyota Hi-Ace Grandia Van with Plate No. VAA 2397 has an estimated value of Php1,500,000.00. The same identified discrepancy was mentioned in our memorandum dated March 29, 2022 *(hereto attached)* for rectification.

In view hereof, you are instructed to submit the final and/or rectified Seizure Receipt also the Seizure Order indicating the final amount of estimated fair market value of apprehended forest product. Though, the fair market value of the apprehended conveyance is just a reference for the PENRO Appraisal Team, Still, the indicated amount of Php1,500,000.00 is quite high.

SUBJECT	:	APPRAISAL REPORT OF APPREHENDED TOYOTA HI-ACE GRANDIA VAN WITH PLATE NUMBER VAA 2397 LOADED WITH 25 SACKS OF ALMACIGA RESIN WITHOUT ANY LEGAL DOCUMENTS/PERMITS

This pertains to your Memorandum dated March 23, 2022.

You are requesting for appraisal of the apprehended Van with Plate No. 2397.

Using the current market value (CMV) taken from advertise prices of used vehicle of the same make and model from (Get Used Toyota Hiace (2015-2018) 35442 Price & Sellers Information I Carmudi – 2017 Toyota Hiace Quezon City Updated on March 21, 2022), (Get Used Toyota Hiace (2015-2018) 34170 Price & Sellers Information I Carmudi – 2017 Toyota Hiace Caloocan City Updated on March 21, 2022), and (Get Used Toyota Hiace (2015-2018) 20696 Price & Sellers Information I Carmudi – 2017 Toyota Hiace (2015-2018) 20696 Price & Sellers Information I Carmudi – 2017 Toyota Hiace Quezon City Updated on March 18, 2022). The appraised value of van is **Php686,158.19**.

However, in your seizure receipt, you quoted the estimated value of the van as Php1,500,000.00. May we know what was the basis of your estimated value was? Please take note that the estimated value in the seizure receipt is the basis for valuation of the Regional Office in the issuance of confiscation order. Should there be over estimation, this will bloat the amount of confiscated/seized goods booked in our book of accounts.

Likewise, we observed that you have submitted two different seizure receipts. The first one is dated March 29, 2021. The twenty five (25) sacks of Almaciga resin has an estimated value of Php37,500.00. The van has no estimated value.

The second seizure receipt is dated April 14, 2021. The twenty five (25) sacks of Almaciga resin has an estimated value of Php30,000.00 and the van with plate number VAA 2397 has an estimated value of Php1,500,000.00.

Please review your report properly and verify accordingly.

This is to acknowledge receipt of your Memorandum dated September 28, 2022 and its enclosures regarding the above subject.

Per evaluation of the submitted documents, it was noted that the concerned CENRO submitted two (2) different Seizure Receipts dated March 29, 2021 and April 14, 2021. Discrepancies in the fair market value (FMW) of the conveyance and forest products were observed in both Seizure Receipts. Further, the declared FMV of the apprehended conveyance is Php 1,500,000.00 in the Seizure Receipt while the computed appraisal value of the subject conveyance is Php 548,926.55 based on the assessment conducted by the Appraisal Committee.

In this regard, kindly resubmit the Seizure Receipt indicating the amount of Php 548,926.55 based on the said assessment considering the 125% cash bond of Php 686,158.19 posted by the registered owner. Also, include the accurate FMV of the apprehended forest products to address the discrepancy in the submitted Seizure Receipts.

SUBJECT	:	ADMINISTRATIVE ADJUDICATION OF APPREHENDED ONE (1) UNIT WHITE TOYOTA GRANDIA WITH PLATE NO. VAA 2937 LOADED WITH TWENTY FIVE (25) SACKS OF ALMACIGA RESIN APPREHENDED AT ANILAWAN PNP SUB-STATION, BARANGAY BABUYAN, PUERTO PRINCESA CITY ON MARCH 27, 2021.

Respectfully forwarded are the memoranda of CENRO Puerto Princesa, Palawan dated January 5, 2022, February 15, 2022, March 23, 2022 and September 23, 2022 relative the above subject.

Per memoranda, the apprehension was made on March 27, 2021 around 8:00 A.M. at Anilawan PNP Station, Barangay Babuyan, Puerto Princesa City, Palawan by the elements of Anilawan PNP Sub-Station and then turned-over the apprehended items to CENRO Puerto Princesa for safekeeping purposes. The team apprehended the one (1) Unit Toyota Grandia with Plate No. VAA 2397 loaded with undocumented twenty-five (25) sacks of Almaciga Resin with fair market value of Php1,500,000.00 and Php37,500.00 respectively. The vehicle is owned by Mr. Rodivico S. Zabanal and the driver is Mr. Mervin B. Cerrera.

Notices of hearings were sent to the respondents and the hearings were conducted on April 14, 2021, July 28, 2021 and August 23, 2021 in relation to Section 7, Item No. 1 of DAO 1997-32. Further, Mr. Zabanal requested the release of his apprehended vehicle thru letter dated September 14, 2021 and finally on March 25, 2022 the PENRO Appraisal Team conducted the appraisal and the recommended bond is amounting to Php686,158.19.

The PENRO Appraisal Team recommended for the temporary release of the subject conveyance thru memorandum dated March 25, 2022 with PENRO memorandum dated March 29, 2022 with the bond of Php686,158.19 pursuant to DAO 1997-32 and finally, on March 29, 2022 the Order for temporary released was issued and the conveyance owner paid the total amount recommended with Official Receipt No. 1411455 dated March 29, 2022.

We concur with CENRO recommendation for the temporary release of the conveyance subject to the provisions of DENR Administrative Order 1997-32 and to file appropriate charges against the perpetrators before the City Prosecutor's Office.
