It was observed during the ocular inspection that you have constructed a structure within the twenty (20) meter salvage zone. Such structures are in violation of Art.51 of PD 1067, Section 105 of PD 1096 and DENR Administrative Order No. 97-05 as amended by DAO 99-21 and Section 30 of R.A. 7279 which prohibits permanent structure within salvage zone (legal easement) as defined under Sec. 51 of PD 1067.

In view hereof, you are hereby instructed to vacate the said area and to conduct voluntary self-demolish of the established structures.
