





RESOLUTION

For resolution is the *Partial Motion for Reconsideration* dated July 17, 2019 filed by the Protestee thru counsel, from the Decision dated May 10, 2019 issued by then Regional Executive Director Henry A. Adornado. The dispositive portion of which is hereunder quoted:

"WHEREFORE, premises considered, AFTER the lifting of the Memorandum dated May 28, 2015 of the Undersecretary for Field Operations¹, the PENR Officer/CENR Officer concerned is hereby directed to:

1. **GIVE DUE COURSE** to FPA No. (IV-27) 461 of Angel Ora over Lot 6827, Cad 799-D;
2. **REJECT** FPA No. (IV-27) 869 of Stephen Ora over Lot 6834 Cad 799-D; and
3. Protestant Antonio Goh is **DIRECTED TO FILE** the appropriate public land application over Lot 6834."

A Vehement Opposition to Protestees' Partial Motion for Reconsideration dated August 9, 2019 was submitted by the Protestant thru counsel.

Perusal of the Motion shows that the issues raised therein do not make out a new matter sufficiently persuasive to induce modification of judgment. As such, we find no ground or cogent reason to disturb and/or modify the Decision dated May 10, 2019.


Per Memorandum dated March 02, 2020 of then Undersecretary for Field Operations, Enforcement and Muslim Affairs Jim O. Sampulna, the latter lifted the suspension in the issuance, processing and approval of survey authority, survey plans, and Public Land Applications of
