Greetings of peace from NCIP!

We are respectfully transmitting herewith the excel file containing the following:

1. List of approved CADT/CALT applications, with their locations;
2. List of on-process CADT/CALT applications, with their locations;
3. List of CADT/CALT applications for processing, with their locations.

The attached letter and the enclosed/attached data shall serve as a formal notice to LRA (and Register of Deeds), DENR and DAR as to the existence and location of all known ancestral domains/ancestral lands (ADs/ALs); and shall constitute a formal opposition to all titling and registration proceedings/activities undertaken within said ADs/ALs by the LRA/RoD, DENR and DAR. Consequently, the NCIP and the concerned Indigenous Cultural Communities/Indigenous Peoples (ICCs/IPs) are deemed legally entitled to all notices pertaining to titling and registration proceedings being undertaken, or to be undertaken, by the aforementioned agencies insofar as titling and land registration activities are concerned.

Likewise, the NCIP and ICCs/IPs concerned hereby reserve the right to file the necessary civil, administrative, and criminal actions, as the case may be, against all responsible persons, in case of violation of any of the rights of the ICCs/IPs enshrined in the Constitution and in the Indigenous Peoples Rights Act (IPRA) of 1997.
