Respectfully submitted is the performance evaluation report on the Socialized Industrial Forest Management Agreement (SIFMA) and Forest Land Grazing Management Agreement (FLGMA) issued within the administrative jurisdiction of CENRO's San Jose and Sablayan, Occidental Mindoro.

#### METHODOLOGY:

The team had an advance coordination with the Chiefs/personnel of the Compliance and Monitoring Units of CENRO's San Jose and Sablayan for the conduct of the compliance monitoring and performance evaluation activities within their respective areas of jurisdiction. Courtesy calls with the PENR Officer of Occidental Mindoro and the CENR Officers of San Jose and Sablayan were also initiated, who in turn, provided the necessary assistance to the team. The team proceeded first to San Jose, then to Abra De Ilog, Occidental Mindoro.

#### FINDINGS AND OBSERVATIONS:

- Six (6) SIFMA Holders, namely: Winston Ebersole, Mindoro Lodge No. 157 c/o Ramon Espada, Ernesto Pagayatan, Washington Sy, Benigno Cabillo and Pablo Frani will expire in December 2023.
- Said SIFMA holders failed to pay the annual rental dues, interests, and penalties from 1998 to 2022 and to submit Annual Report/s as to the status and development of the contracted area to the DENR.
- 3. As to SIFMA No. DENR-IV-17-0003 of Mr. Winston Ebersole, the Monitoring and Evaluation Team of CENRO-San Jose recommends for the termination of the

heirs did not show any interests to continue the same, by not filing their application within six (6) months after the death of the proponent/holder. There was also failure to submit annual report/s as to the status and development of the area, and to pay annual rental fees and penalties.

- 4. As to SIFMA No. DENR-IV-17-0002 of Mindoro Lodge No. 157 c/o Ramon Espada, the Monitoring and Evaluation Team of CENRO-San Jose recommends for the termination of the agreement since the proponent/holder failed to submit annual report/s as to the status and development of the area and to pay annual rental fees and penalties.
- 5. As to SIFMA No. DENR-IV-17-0002-98 of Mr. Ernesto P. Pagayatan, the Monitoring and Evaluation Team of CENRO-San Jose recommends for the termination of the agreement, since the proponent/holder was already dead, and his legal heirs did not show any interests to continue the same, by not filing their application within six (6) months after the death of the proponent/holder. There was also failure to submit annual report/s as to the status and development of the area and to pay annual rental fees and penalties.
- As to SIFMA No. DENR-IV-OCCMIN-0005-98 awarded to Mr. Washington Sy, the herein proponent/holder, through an undated letter, voluntarily relinquished/cancelled his right/s over the subject property.
- 7. As to SIFMA No. DENR-IV-OCCMIN-0004-98 of Mr. Benigno Cabillo, the Monitoring and Evaluation Team of CENRO-San Jose recommends for the termination of the agreement, considering that he proponent/holder failed to submit annual report/s as to the status and development of the area and to pay annual rental fees and penalties.
- 8. As to SIMA No. DENR-IV-OCCMIN-0001-98 of Mr. Pablo Frani, the Monitoring and Evaluation Team of CENRO-San Jose recommends for the termination of the ageement, considering that the proponent/holder failed to submit annual report/s as to the status and development of the area and to pay annual rental fees and penalties.
- 9. As to the FLGLA No. 754 of Mr. Verne Zafra, the proponent/holder, through Mr. Leovigildo "Obet" De Ocampo, representative/In-charge of the grazing area, has maintained and developed the area. Cattles was visible. He also established headquarters for his two (2) hired cowboys, who utilized cellular phones as a means of communication from the grazing area to the ground. As to the payment of rental fees, the proponent/holder has timely paid the same on a cash basis. The only deficiency that was noticed, is the non-submission of Grazing Management Plan, and the non-issuance on the part of NCIP of the Certification Precondition/FPIC.

In view of the aforementioned, the Regional Monitoring Team recommends the following:

 The cancellation/termination of SIFMA contracts awarded to Mr. Winston Ebersole, Mindoro Lodge No. 157 c/o Ramon Espada, Mr. Ernesto P. Pagayatan, Mr. Washington Sy, Mr. Benigno Cabillo and Mr. Pablo Frani based on said findings;

- 2. The renewal of FLGLA No. 754 of Mr. Verne Zafra, who maintained and developed the leased area; and
- CENRO-Sablayan should advise and provide the necessary assistance to the proponent/holder, to submit the lacking documents (Grazing Management Plan/Certification Precondition/FPIC) as required in the terms and conditions of the contract.
- The Regional Office will further discuss the findings and recommendations of the team to come up with appropriate actions that will serve the best interest of the government.

Upon arrival, the team had a courtesy call with the PENR Officer of Occidental Mindoro and the CENR Officers of San Jose and Sablayan, who in turn, provided the necessary assistance and logistics to the team.

The undersigned would like to acknowledged the collective efforts of the Enforcement and Monitoring Units personnel of CENRO's Sablayan and San Jose who worked hand in hand with the team for the accomplishment of the task at hand.

### **ACTIVITIES/ACTIONS TAKEN:**

The team, assisted by Foresters Hector S. Aragones, Jr., Jomar B. Serquiña, Forest Technicians Dominic L. Vidal, Loren Kaye A. Garcia and Forest Rangers Emmanuel G. Ignacio, Carl Emmanuel A. Urieta, Delfin N. Casticimo, Jr. and Ronald D. Fresnillo, proceeded first to San Jose, Occidental Mindoro to conduct performance evaluation on the following SIFMA holders whose contracts will expire in December 2023:

- a.) Winston Ebersole (SIFMA No. DENR-IV-17-0003) Brgy. Poypoy, Calintaan, Occidental Mindoro
- b.) Mindoro Lodge No. 157 do Ramon Espada (SIFMA No. DENR-IV-0006),

#### FINDINGS:

- 1. CENRO-San Jose submitted regular Compliance Monitoring Report/s with remarks and recommendations<sup>2</sup>:
- Four (4) SIFMA holders, namely: Winston Ebersole, Mindoro Lodge No. 157 c/o Ramon Espada, Ernesto Pagayatan and Washington Sy will expire in 2023;
- Said SIFMA holders failed to pay the annual rental dues, interests, and penalties from 1998 to 2022 and to submit Annual Report/s as to the status and development of the contracted area to the DENR;
- 4. As to SIFMA No. DENR-IV-17-0003 of Mr. Winston Ebersole, the Monitoring and Evaluation Team of CENRO-San Jose recommends for the termination of the agreement, considering that the proponent/holder was already dead, and his legal heirs did not show any interests to continue the same, by not filing their application within six (6) months after the death of the proponent/holder. There was also failure to submit annual report/s as to the status and development of the area, and to pay annual rental fees and penalties.
- 5. 




