
This refers to your memorandum dated November 11, 2021 regarding the above subject. We have sought comments from PENRO Marinduque, the mother unit of Forester Joven. In a memorandum dated December 9, 2021, said office stated strong objection on the extension of reassignment of Forester Joven to PENRO Quezon due to the following reasons:

1. Based on DENR Special Order No. 2021-101 dated March 5, 2021, Forester Joven was given reassignment to PENRO Quezon for six months only or until September 5, 2021, but she has not since reported back to her mother unit; and
2. PENRO Maridnuque is in need of Foresters following the retirement of the Chief of the Monitoring and Enforcement Section of the Technical Services Division.

Anent the above, and in order to ensure efficient manpower complement in PENRO Marinduque and uninterrupted service delivery, we request that a memorandum be issued to For. Joven ordering her to comply with the provision of SO No. 2021-101 and immediately report to PENRO Marinduque.
