Please be informed that the BMB IPAF Review Committee has already deliberated the said proposals on 26 January 2022 pursuant to BMB Technical Bulletin No. 2021-03 on the *Guidelines on the use of Protected Area Retained Income Account (PA-RIA), Special Account in the General Fund (SAGF), and Protected Area Trust Receipts (PA-TR) and providing the criteria for the allocation of funds under the IPAF-SAGF in the National Treasury.*
