I. BACKGROUND

On June 7, 2021, this Office received an e-mail complaint from Paul Hudson Acha Jaranilla alleging therein that the Rabang family violated what was agreed upon during their hearing in CENRO-Roxas, last April 6, 2021, that no party should make any activity in the disputed land without the presence of both parties so as the Barangay Officials and DENR personnel. According to Mr. Jaranilla, the Rabang family made some clearings in the subject area and thereon erected fences neither notifying nor informing the Jaranilla's party. Thus, Mr. Jaranilla requested this Office to halt the said activity.

On July 6, 2021, the CENRO-Roxas team launched an investigation on the complaint of Mr. Jaranilla. The team found out that there were cut poles near the tree stumps in the subject area. The team inventoried these cut poles and identified it as species of Basa, Bunot-bunot, Putat and Kansilay. When the team checked the barbed wire posts which were used as fences, they observed that said posts were probably cut more than a year ago as it shows some decays. Moreover, the team concluded that the barbed wire posts were possibly obtained from another area since the number of posts did not match the tree stumps seen in the subject area.

In an interview with Mrs. Mildred Rabang-Casencia, daughter and representative of Mrs. Belinda Rabang, she averred that they got the barbed wire posts from an approved tree plantation of Mr. Florentino Casencia in So. Pamuayan, Bgy. Port Barton.

Based on the findings of the team, they recommended that an administrative hearing shall be conducted to further elicit information on the herein subject matter.

III. COMMENTS

1. The CENRO-Roxas was constrained not to furnish the official scaling report to Ms. Marle A. Jaranilla as it is still the subject of an on-going investigation. Pursuant to Item no. 8, Annex C of DENR DAO 2016-29, investigation proceedings may not be disclosed if the premature disclosure thereof may pre-empt the resolution of the case. The scaling report forms part of the investigation proceedings as it may be used as a basis in filing the appropriate criminal charges. In addition thereto, Ms. Jaranilla did not clarify her purpose in securing the scaling report. Thus, the CENRO-Roxas decided to withhold the said report as release thereof may prejudice the actions that may be undertaken by this Office on the herein matter.

Concepcion (Attached hereto as Annex "I").

As to the furnishing of the scaling report to Atty. Julius M. Concepcion, please be informed that only the tabular inventory of the scaled forest trees was provided to the former and not the official scaling report. According to Atty. Concepcion, said scaling will only be used for guiding Ms. Jaranilla in her path of actions on this matter. Thus, what was provided to them were only information regarding the scale of inventoried cut trees from the scaling report.

IV RECORDS

1. In letters of 11 March and 22 April 2020 (Annexes 1 and 2) received by the Office, Ms. Jaranilla narrated (both paragraph 5 of the letters) that in the year 2000, she requested and paid for survey (of land apparently in Port Barton). That she was issued respective titles over the resultant lots except over Lot 6, the one immediately bounding the property of one Belinda Rabang. Ms. Jaranilla continued that when she visited the Office in March 5 to inquire of the status of Lot 6 of Ccs. 04-

000297-D, she was informed (by a representative of the Office seemingly) that Belinda Rabang filed a complaint (par. 3 and 9 of the letters) against her involving a piece of land which does not belong to

her. In par. 7 of her second letter, she was already aware that her application was overtaken by the moratorium on public land titling (the very answer to par. 8 of her first letter seeking explanation what caused the delay in the processing of her application1).

- 2. In May and December 2020, while the moratorium on public land activities remains in effect in San Vicente, this Office sent Ms. Rabang letters (copy attached as Annexe 3 and 4) giving her space within which to comply with what were required of objections against public land applications.
- 3. The same information which Ms. Jaranilla already knew were also reminded of her in Office letters of December 2020 and January 2021, each a copy of which are hereto attached as Annexes 5 and 6.
- 4. In a memorandum of 08 February 2021 (Annex 7) and a letter of 06 August 2021 (Annex 8) the Regional Office and the provincial government were likewise made aware of premises surrounding the matter.

V LAW

Section 95 of the Public Land Act provides that should a tract of land be found occupied by a claimant other than the applicant, land officials are expected to give the occupant prior right to apply when qualified. Section 102 thereof provides that objections may be filed against any public land application grounded on issues sanctioned by the Act.

VI OBSERVATION

While it is not uncommon for inspecting officers advising lot claimants of making sure lot corners are accessible for site validation, one in the right mind especially coming from the DENR would never order clearing prohibited trees especially those belonging to another person. The Office only facilitates interests over lands free from adverse claims and/or conflict. One's inability to maintain physical care of a land claim cannot be faulted upon another, including government employees.

VII RECOMMENDATION

Just as before, to advise Ms. Jaranilla to tarry until the prohibition in titling activities in the area is finally lifted and/or leave the matter to the Barangay or Provincial Governments on interests she may have waived in the their favor, if any.

MS. MARLE JARANILLA RE; CUTTING OF TREES USED AS BARB WIRE POST IN FENCING LOT NO. 6 SITUATED IN BARANGAY PORT BARTON, SAN VICENTE, PALAWAN.

Please be informed that on July 6, 2021 the undersigned proceeded to Barangay Port Barton, San Vicente, Palawan to conduct verification on the cut trees requested by Mrs. Marle A. Jaranilla to be scaled.

Based from the letter request of Mrs. Jaranilla dated June 24, 2021 the trees were cut by Belinda Rabang and family in order to be used as barbed wire post to fence Lot No. 6.

Around 11:00 AM the undersigned together with Barangay Tanods Mr. Dennis Austria and Mr. Maximo Batistel, Mr. Anatalio Hinayon representative of Mrs. Jaranilla, and Mrs. Mildred Rabang Casencia daughter and representative of Mrs. Belinda Rabang, are all gathered outside the fence while the undersigned is conducting inspection of the wood used as barbed wire post therein and also conducting interview to Mrs. Casencia.

The undersigned noticed that the said wood used as barbed wire post is Putat in local name, under the group of Miscellaneous Species, in saplings sizes, and observed that the woods were cut a year ago which some of these woods are showing decaying process. During interview, Mrs. Casencia mentioned that the wood used as barbed wire posts during the installation of the fence was acquired from the approved Tree plantation of Mr. Florentino Casencia situated in So. Pamuayan also jurisdiction of the same Barangay, the said wood were affected during the cutting and felling of Mangium trees.

The team entered the fenced area with permission given by Mrs. Casencia for verification of the undersigned on the stump of cut trees used as barbed wire posts of the fence as stated in the letter request of Mrs. Jaranilla. The undersigned inventoried cut poles of Basa, Bunot-bunot, Putat, and kansilay species, these said cut poles were stack near its stumps and not used as barbed wire posts of the fence.

According to Mrs. Casencia, during their hearing/meeting last April 6, 2021, they volunteered on the cleaning of the area for the inspection of the personnel of this Office.



Based from the actual verification of the undersigned in the area, the abovementioned cut miscellaneous saplings and poles inside the area were not utilized as barbed wire posts of the fences, and the used posts of the barbed wire in the fences have the possibility that they were obtained from another area because there were only few stumps seen inside the area.

The undersigned observed that Section 77 of Presidential Decree 705 as amended by Republic Act 7161 was violated in the cutting of the mentioned poles and the wood us as barb wire post. The undersigned hereby recommend that administrative hearing must be conducted for the both parties to determine the perpetrators.







Referring to the complaint subject hereof, please be informed that as before instructed this Office has addressed the same in letters of 14 December 2020 and 14 January 2021 each a copy of which are hereto attached as ANNEXES A, B, and C.

It appears that when the subdivision Jaranilla herself sought was allowed and conducted, the surveyor found out that the line separating Lot 5034 and Rabang's Lot 4643 is not consistent with the actual situation on the ground hence, the inclusion of Rabang's claim in the subdivision correcting the discrepancy by making it conform seemingly to that which Jaranilla identified on site. It consequently diminished Rabang's original area, the only reason seen of the latter's letter requesting to hold processing of Jaranilla's application over the portion affecting part of Lot 4643 and hence, ANNEX B hereof.

Owing however to the moratorium on Public Land Titling in San Vicente, this Office can only recommend that Jaranilla be advised to secure the premises of Lot 6, Ccs. 04-002297-D so as to keep visible especially the line separating Lots 6 and 7 in anticipation of the prohibition's final lifting.

Jaranilla over the aforementioned land was held on account of a letter turned-in by Ms. Belinda Rabang for alleged overlapping, the latter has yet to present a documentary form of evidence in support of her claim despite notice (copy attached), only then shall this Office entertain her objection in due form as referred to in Section 4 of DENR Admin. Order No. 2016-31.

As government projects are exempted from coverage of the moratorium on public lands yet in effect in the Municipality of San Vicente, the Bgy. Government of Port Barton may either come up with a resolution seeking proclamation thereof, or begin appropriating its use should the Council opt to directly secure a Special Patent thereof by also coming up with a resolution requesting the Municipal Council to request the Special Patent desired via a resolution of its own, Bgy. LGUs not being among those listed to whom Special Patents may be issued.
