Further to BMB Memorandum dated 10 February 2022, informing your respective Offices on the results of the IPAF Review Committee for priority protected areas for funding under the IPAF-SAGF for FY 2022, the BMB through the National Parks Division will conduct an online workshop for the six (6) PAs via Zoom and a three-day face-to-face workshop for the three (3) PAs with the following objectives:

- 1) Provide technical assistance to priority protected areas for funding the IPAF-SAGF;
- 2) Ensure that all the supporting documents are satisfactorily complied with by the concerned PA Management Offices and Regional Offices;
- 3) Fast track the completion of SBR package for endorsement to DBM; and
- 4) Conduct site monitoring and validation of proposed activities.

The handholding workshop will be held on February 18, 2022 through an online platform for the protected areas that are already in the finalization stage of their Special Budget Request Packages. On the other hand, we intend to conduct a three-day workshop for each of the protected areas that are still in the initial stage of preparing their SBR packages.
