Respectfully referred herein letter sent thru email dated February 11, 2022, coursed thru the DENR Action Center/Hotline from **Mr. Pedrito Nepomuceno**, former Mayor of Boac, Marinduque <pedritomnepomuceno@yahoo.com> pertaining his follow-up on his previous letter complaint re: Delivery truck with "Food Pass" signage accidentally spilled "questionable" lumber, bearing PCC Code No. PCC-CYR-09-13-2021-211. On his previous responses regarding the referral of the Assistant Secretary for Field Operations – Luzon and DENR IV-B Regional Office of this complaint to PENRO Marinduque, Mr. Nepomuceno reiterated that the incident did not happen in Marinduque, while PENRO Marinduque also claimed on their email dated 20 August 2021 that the said incident happened in Brgy. Tigatto, Davao City "*as per search in different Facebook posts*". With this, Mr. Nepomuceno is requesting for appropriate action, consistent with existing laws, rules and regulations to address this complaint immediately and be acted upon by the concerned office.

Kindly inform directly the complainant of action taken in this regard furnishing the PCC and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.


