- Submitted updates to the MIMAROPA Region re on the filed criminal complaint against Messrs. Ibuna, Bernardo and Beltran in violation of Section 78 of PD 705 in Snake Island;
- Performed as secretariat during the Technical Working Group Virtual Meeting of Snake Island on January 21, 2022 re response to the aftermath of Typhoon Odette in Snake Island;
- Assisted the Office of Civil Defense during their site assessment in Snake Island on January 22, 2022 re the damages brought by Typhoon Odette in the island;
- Continues revision on the drafted Snake Island Operational Plan 2023-2027;
- Assisted in the preparation of contracts for Snake Island NCMCR Job Orders from January to June 2022.
- Travelled to Snake Island to supervise and facilitate the clearing of debris brought by super
 Typhoon Odette.
- Assisted in the repair of the roof and inside ceiling of the Main Admin. Building of Snake Island NCMCR on January 15, 2022.
- Checked and followed up with the mechanic regarding the updates to the speedboat's engine.











