

30th MEETING OF THE TASK FORCE BUILD BACK BETTER (TFBBB) February 17, 2022 | 10:00 AM Via Zoom Platform

SUMMARY OF AGREEMENTS/ACTIONS NEEDED

1. Matters arising from the previous meeting

- a. CARAGA
- DENR to come-up with a plan and identify different targets for the adoption and assistance from Philip Morris, and targets under the National Greening Program.
- Refine figures in the proposed budget in the financial requirement of target programs.

2. Resettlement Plan for Siargao and Dinagat

- a. Updates of the Shelter Cluster of NDRRMC on Typhoon Odette Interventions
- DENR to initiate the review of available lands and prepare master listing of land inventory for 24 vulnerable provinces.
- The Shelter Cluster of the NDRRMC headed by DHSUD will convene a meeting to discuss the possible revision of criteria selection of beneficiaries for resettlements due to limited availability of NDRRM fund.

Other Matters

- a. Highlights of the 14th February 2022 meeting between NDRRMC and the National Secretariat of Task Force Build Back Better, and Proposed Next Steps
 - Agreement to identify a framework of collaboration and assistance of TFBBB in the PDNA;
 - Proposed to include the environmental dimension (e.g. coastal resources and mangrove assessment) in the PDNA apart from agriculture and fisheries;
 - Alignment of TFBBB KRAs and NDRRMC clusters and sub-clusters;

- Agreed to hold a joint meeting on mid-March FY 2022, between OCD, DENR, and Heads of Regional TFBBB, to define coordination flow between the two bodies;
- Clarification on the funds flow, since several requests for funds were received by DENR from LGUs, which were formerly referred to DBM for consideration. It was agreed that the proper flow is to submit the request to NDRRMC for their evaluation and if it is included on the prioritization matrix, and for endorsement to the Office of Secretary Lorenzana and the Office of the President.
- b. To be discussed in the next meeting:
 - 1. DENR CARAGA to adjust the Action Plan regarding the rehabilitation of mangroves in the area (assistance of Philip Morris), vis-a-vis the NGP implementation; and to consider the immediate assistance thru a cash-for-work program through the assistance from Philip Morris (e.g. include names of recipient to conduct the clean up of debris/garbage);
 - 2. DENR FMB to report updates on proposed policy related to the issues raised on the recovery of typhoon-damaged trees and sawmills;
 - 3. Issue on funding to be reported; and
 - 4. DENR LMB to spearhead the land inventory and present the action plan, particularly for the 24 vulnerable provinces.
