Greetings!

In line with the Philippine Association of Records Officers and Archivists (PAROA) efforts during this time of pandemic is to deliver virtual information to our previous participants who are inquiring and requesting for us to conduct a virtual training. The Association believes in the potential of digital platforms which have not only helped ease the fears and feeling of isolation in a different community, but it has also more importantly become instrumental in providing information, mobilizing help and directing efforts where it is needed.

We are glad that both the National and Local Government entities are pushing hard to broaden the employee's access to various technological platforms in these trying times. PAROA, in its efforts to provide you with the needed information is having its CY-2022 first quarter virtual seminar, entitled: **"Virtual Training/Seminar on Electronic Records Management System for the Local Government with the "Devolved Basic Services" and How to Operationalize the Electronic Records Management Policy in this Context"**. Under the full devolution, many good things are coming our LGUs' way, such that LGUs are given local autonomy, more powers, authority and the corresponding financial resources, among others. However, with devolution comes greater responsibilities to our LGUs, such as, how can they become more accessible to the general public with the transfer of basic services and facilities to them. They need to adopt certain mechanisms such as conversion to electronic transactions to ensure the continuous and prompt delivery of public services.

We are cordially inviting Local Chief Executives, Department Heads, Administrative Officers, Budget Officers, Records Officers, Information Officers and other personnel/staff in-charge in the provision of frontline public services to attend this virtual training.

Please note though that due to the pandemic, and in effect, there are various restrictions put in place by the government, but, we assure you that all the materials for the said seminar will be provided thru email.
