How to Fill-Out the RRP-PCB Forms?

<u>Form OM-15: CCAM-DRR PCB Form No. 1 (RRP-prescribed)</u> <u>Program Convergence Budgeting Agency Program/Activity/Project (P/A/P) Description</u>

- 1. Indicate the name of the Department or Agency filling up the form.
- 2. Specify the title of the proposed Program/Activity/Project (P/A/P).
- 3. Put the Unified Accounts Code Structure or UACS of the P/A/P.

Note: UACS is a government-wide harmonized budgetary, treasury and accounting code classification framework jointly developed by the Department of Budget and Management (DBM), the Commission on Audit (COA), the Department of Finance (DOF) and the Bureau of the Treasury (BTr) to facilitate reporting of all financial transactions of agencies including revenue reporting.

- 4. Indicate the appropriate CC Typology Code for the proposed P/A/P using the <u>National CCET Typology Code Manual.</u>
- 5. Classify the P/A/P according to the following and check the appropriate box:
 - a. Existing P/A/P (Tier1) covers ongoing P/A/Ps and commitments at the same scope and quantity
 - b. Existing P/A/P for expansion allocation of fiscal space for new P/A/Ps or expansion of existing P/A/Ps in terms of scope, beneficiaries, timeframe or outputs
