It is a Mandatory Training Course required for Safety Officers under DO 198-18 (RA 10058 "An Act Strengthening Compliance with the Occupational Safety & Health Standards and Providing Penalties in Violation thereof"), Department Order 16 & Rule 1030 of the Occupational Safety and Health Standards (OSHS) as amended.

For companies with below 10 employees, you will undergo BOSH for SO1 for micro and small enterprises.

For companies with 10 and above employees, you will undergo BOSH for SO2 for Medium to Large Industries.

This certificate can be used in case the DOLE would inspect your store.

We also have other trainings like for Construction Industries we have Construction Occupational Safety & Health Training for Safety Officer 2, LCM+HIRAC and SHPA for Safety Office 3 and International Courses.
