Covering Three Point Two Hundred-Six (3.206) hectares of forest land, located at Cadlao Island, Barangay Buena Suerte, El Nido, Palawan pursuant to Section 1838 of Republic Act No. 2711, as amended by E.O. 292, known as the Revised Administrative Code, as amended by Section 57 of P.D. 705, as amended and DAO No. 2004-28, for a period of twenty- five (25) years to expire on December 30, 2030.

This Forest Land Use Agreement for Tourism purposes (FLAgT) made and entered into by and between the OIC, ASEC for Field Operations Concurrent Regional Executive Director of DENR IV-MIMAROPA REGION, <u>VICENTE S.</u> <u>PARAGAS, CESO III,</u> for and in behalf of the Republic of the Philippines, hereinafter called the LESSOR, and TEN KNOTS PHILIPPINES INC. (TEN KNOTS DEVELOPMENT CORPORATION), represented by <u>MR. ALBERTO A.</u> <u>LIM</u>, President, with Office address at 2nd Floor Builders Centre Building, 170 Salcedo Street, Legaspi Village, 1229 Makati City, as the LESSEE.

WITNESSETH

That the LESSOR, as Regional Executive Director of DENR IV-MIMAROPA, acting under the authority of Section 1838 of Republic Act No. 2711, as amended by E.O. 292, known as the Revised Administrative Code, as amended; Section 57 of P.D. 705, as amended and DAO 2004-28, hereby grants to the LESSEE a FOREST LAND USE AGREEMENT FOR TOURISM (FLAgT) PURPOSES (BATHING ESTABLISHMENT) for a period of TWENTY-FIVE (25) years to expire on December 30, 2030, covering an area of THREE POINT TWO HUNDRED-SIX (3.206) hectares of forest land, located at Cadlao Island, Barangay Buena Suerte, El Nido, Palawan, the description and boundaries shown in the attached sketch/map, which forms part of this FLAgT, subject to the following conditions:

- Within six (6) months from the issuance of the FLAgT, the holder shall delineate and mark on the ground the boundaries of the FLAgT area and its zones, subject to verification by DENR, and shall preserve the monuments and other land marks indicating corners and outlines along the boundaries and within the confines of the area covered by the FLAgT;
- All. The holder shall submit within three (3) months from the issuance of the FLAgT, a Site Management Plan (SMP) for the protection of the environment and conservation of natural resources in the area. The SMP shall be accompanied with a performance bond determined based on procedures for special forest land uses;
- III. The holder shall immediately secure the required Environmental Compliance Certificate (ECC) and other necessary permits prior to conduct of any activity in the area;
- The holder shall utilize the area for the purpose for which the IV. FLAgT is granted. In the event that the area will be utilized for other purpose/s other than what is approved, said use is subject to the prior approval of the Secretary or his/her duly authorized representative;
- V. In all instances, cutting of trees within the FLAgT area shall be subject to prior clearance by the DENR in accordance with existing rules and regulations;
- VI. The holder shall strictly adopt ecological solid waste management and abide with the provisions of the Clean Water Act:
- VII. The FLAgT holder shall protect all biodiversity in the area. especially those unique, rare and endangered flora and fauna identified as such under existing laws, rules and regulations;
 - To inform the RED or his duly authorized representative on any changes in the management, ownership or capital stock of the company or corporation or transfer of a majority of the stock or share of the company or corporation as provided for in PD 705, as amended:

- IX. To surrender to the RED or his duly authorized representative, the agreement if not to be renewed on the date of expiration, or if the holder is no longer interested in the area, or in case of cancellation, immediately after the effectivity of its cancellation;
- X. In case of death of individual FLAgT holder, the heir may apply for the transfer of FLAgT within ninety (90) days upon his death;
- XI. Non-Obstruction to Navigation This FLAgT shall not be construed as permit for the holder to obstruct the free navigation of any stream, creek or river or marine coastal area adjoining or flowing through the area, or to prohibit or interfere with the passage of people along such streams, creeks or rivers or the banks thereof, or to impede the flow and ebb of the tide to and from the interior of the swamps;
- XII. The FLAgT holder shall pay the Government Share, in the amount of <u>P48,090.00</u> which is five percent (5%) of the most recent zonal value of the commercial zone within the barangay/municipality/city or province, whichever is higher and shall be paid within 30 days upon the issuance of FLAgT and annually thereafter within the same month that the FLAgT was issued. Failure to pay within the prescribed period shall be subject to surcharges of 8.33% monthly for late payment or 100% for one (1) year.
- XIII. As a guarantee of the faithful performance of and/or compliance with the Forest Laws and Regulations and the terms and conditions of the FLAgT and the payment of the government share thereof, the FLAgT holder shall post a cash bond of **P96,180.00** which is twice (2x) the amount of the government share within three (3) months from the issuance of the FLAgT.

GROUNDS FOR SUSPENSION AND CANCELLATION OF FLAGT:

- 1. Failure of the FLAgT holder to settle administrative dues including government share after three (3) consecutives notices, after they become due and demandable.
- 2. Failure of the FLAgT holder to provide the necessary protection of the area.
- 3. Occupation of FLAgT holder of an area greater or other than that covered by the management agreement.
- 4. For allowing unauthorized person/s to use the area or any portion thereof for purposes other than what is specified in the management agreement;
- 5. If the privilege was obtained through fraud, misrepresentation or omission of material facts existing at the time of filing of the application.
- 6. Abandonment of the area or failure to exercise the privilege granted within the prescribed period of six (6) months from the issuance of the FLAgT without justifiable cause;
- 7. Failure to introduce improvement/development within the prescribed period as indicated in the comprehensive development/management plan.




