SUBJECT : **SUBMISSION OF APPREHENSION REPORT ON ILLEGAL LOGGING, WILDLIFE TRADING AND CASES FILED FOR THE MONTH OF OCTOBER 2021**

Respectfully submitted is the apprehension report on illegal logging, wildlife trading and cases filed for the month of October 2021.

Please be informed that for the month of October, there were a total of 43 apprehensions made in the entire region with more than half in the province of Palawan. The PNP assisted/initiated a total of nine (9) apprehensions, mostly in the province of Occidental Mindoro.

Said 43 apprehensions had a total estimated fair market value of **Php446,249.82** for the forest products excluding the market value of the apprehended units of chainsaw and conveyances. There were 14 units of chainsaw and nine (9) units of conveyances apprehended. Moreover, there were two (2) reported wildlife apprehensions from the province of Palawan which were subsequently released back to the wild.

Further, there were 13 cases filed in court, as follows: three (3) cases filed from the province of Occidental Mindoro while the remaining ten (10) cases filed from the province of Palawan.

Below are the matrixes of summary of Apprehensions for the month of October 2021 (Table 1), and report on Cases Filed for the month of October 2021 (Table 2).

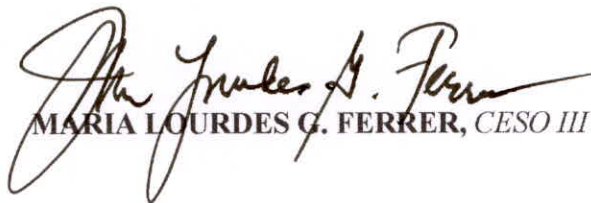

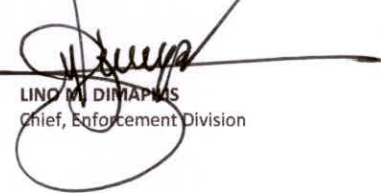

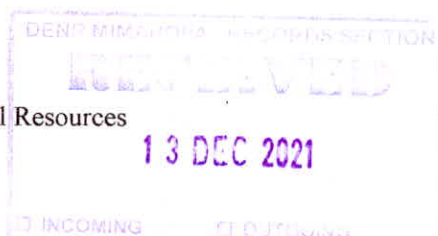

SUBJECT : **SUBMISSION OF APPREHENSION REPORT ON ILLEGAL LOGGING AND CASES FILED FOR THE MONTH OF NOVEMBER 2021**

Respectfully submitted is the apprehension report on illegal logging, and cases filed for the month of November 2021.

Please be informed that for the month of November, there were a total of 36 apprehensions made in the entire region with almost half in the province of Occidental Mindoro. The PNP assisted/initiated a total of 15 apprehensions, mostly in the province of Oriental Mindoro.

Said 36 apprehensions had a total amount of **Php 496,352.68** for the estimated fair market value of the forest products excluding the market value of the apprehended units of chainsaw and conveyances. There were 7 units of chainsaw and five (5) units of conveyances apprehended.

Moreover, there were 12 cases filed submitted for the month of November. The six (6) cases filed were still pending at the Office of the Provincial Prosecutor while five (5) cases were under the Court's litigation, and one (1) case filed was issued an arrest warrant by the Municipal Circuit Trial Court of Quezon-Rizal-Kalayaan against the perpetrator. As of this date, no reported person convicted among the 12 cases filed in the region.

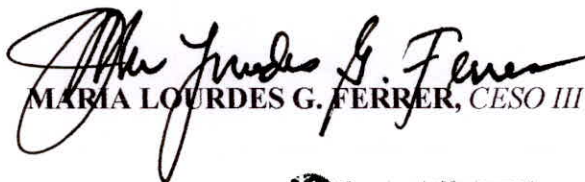
