This pertains to your Memorandum dated 17 December 2021 submitting the annual accomplishment report for CY 2021 on the conducted performance evaluation of CSCs within the Region.

Based on the review of the submitted report, we have noted the following:

1. A total of 2,963 CSCs were evaluated or equivalent to 92.10% of the total target of 3,217 CSCs for evaluation.
2. Out of the 12 CENROs in Palawan, four CENROs accomplished more than their annual target. One CENRO attained 100% accomplishment while the rest of the CENRO's achieved below 100 % with one CENRO attaining 54% accomplishment of their target last year. The high accomplishment of some CENROs compensated for the lower accomplishment by other CENROs.
3. Out of the 2,963 CSCs evaluated, 1,859 CSCs are for renewal, 270 CSCs for re-evaluation, 76 CSCs for transfer to the next- of – kin and 758 CSCs are for cancellation.

In view of the foregoing, we commend the CENROs which attained 100% or more of their target for CSC evaluation. However, for those CENROs lagging behind their targets, it is being recommended to adopt a catch – up plan in order to fast track the CSC evaluation in the region.

Further, please be informed that the DENR Central Office would like to complete the CSC evaluation nationwide by CY 2023. Hence, the Region needs to have additional target for CSC evaluation for the succeeding year. Along this line, please also ensure that the evaluated CSCs have complete and updated information in the Enhanced Forestry Information System (eFIS) for consistencies. In addition, the Region is also being requested to include in the report

policy proposals which are deemed necessary to be crafted or revised/amended based on current realities in the field. Furthermore, please be guided with the following guidelines to properly facilitate the renewal, transfer, re-evaluation and cancellation of CSCs, to wit:

1. Memorandum from the Undersecretary for Field Operations dated 28 November 2013 – Renewal and Cancellation of Certificate of Stewardship Contract (CSC);
2. DENR Memorandum Circular 1993 – 21 – Revised Procedures on the Conduct of Performance Evaluation of Stewardship Agreement, Cancellation and Compensation of the Holders Thereof;
3. FMB Technical Bulletin No. 11 - Supplemental Guide on the Evaluation of Certificate of Stewardship Contracts; and
4. DENR Memorandum Circular 1993-23 - Revised Procedures on the Transfer of Certificate of Stewardship (CS) to the Next-of-Kin of the Holders Thereof.

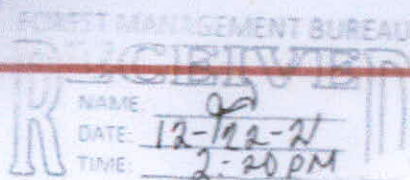


