Dear Sir Aceveda:

Isang makakalikasang araw!

This letter pertains to your query dated 13 January 2022 relative relative to your complaint against the operation of J&R Builders, a hollow blocks production project, in Centro 2, Sta. Rosa 1, Baco, Oriental Mindoro.

In your letter, you are inquiring if the abovementioned project has an existing Environmental Compliance Certificate (ECC), if the proper procedure was taken in the application and issuance of ECC, and if this Office can still take cognizance of your complaint despite the issuance of an ECC to the project proponent.

EMB Memorandum Circular 2014-005 Annex A 2.1.6 (c) provides that non-metallic mineral processing plants like cement, other cement products, clinker, limestone, ceramic industries, manufacture of glass and glass products, manufacture and process of calcium, if the annual production rate is less than 200MT, the said project is not required to secure an ECC.

During the inspection conducted last 07 September 2021, in coordination with the Municipal Environment and Natural Resources Office (MENRO) of the Local Government Unit (LGU) of Baco, it was found that J&R Builders has an annual production rate of 130MT. Thus, they are not covered under the Philippine EIS System and does not need to secure an ECC. It was likewise revealed that no environmental law within the jurisdiction of this Office has been violated.

However, as stated in our previous letter, this Office endorsed theCS complaint to the LGU concerned being that the issue is well within their mandate and jurisdiction. A copy of the endorsement letter dated 04 November 2021 is attached herewith for your ready reference.
