- SUBJECT : Preparation of FY 2023 Budget Proposals

DATE : January 21, 2022

- This is to provide a copy of the National Budget Memorandum (NBM) No. 142 or the National Budget Call for FY 2023 dated January 12, 2022. The Budget Call contains budget parameters earlier set by the Development Budget Coordination Committee as well as policy guidelines and procedures to aid government agencies in the preparation and submission of their budget proposals.
- 2. Section 2.5 of the National Budget Call also states that the AROs shall craft annual regional plans and budgets anchored to the priority criteria stipulated in the NBM 142, coordinating their efforts with the Regional Development Council (RDC) to ensure convergence of regional programs. Moreover, Executive Order No. 325, s. 1996 mandates the RDCs to review and endorse to the national government the annual budgets of agency regional offices (AROs), state universities and colleges (SUCs), and selected government owned and controlled corporations (GOCCs).



- 3. In view of this, we are providing the policy guidelines on the preparation of the FY 2023 Agency Budget Proposals. The guidelines provides the standard procedures, requirements, and schedule of activities in the preparation of FY 2023 budget proposals of AROs, SUCs, and GOCCs.
- 4. We would also like to invite you to the RDC pre-budget consultation on February 04, 2022 (Friday) to discuss the budget call, FY 2023 Annual Investment Program, and the mechanics of the RDC Budget Review and Consultation (refer to attached activity design for details).
