This webinar is in line with the implementation of the Capacity Building on Measurement, Reporting and Verification (MRV) of Climate Change Mitigation Phase 2 being facilitated by the DENR Climate Change Service (CCS) through the Climate Change Information and Technical Support Division (CCITSD). The overall goal of this program is to develop the Measurement, Reporting and Verification (MRV) system for NDC mitigation measures in the Waste and Industrial Processes and Product Use (IPPU) sectors spearheaded by the EMB, through support being provided by the Partnership to Strengthen Transparency for co-Innovation (PaSTI) in order to track progress towards achievement of goals set in the NDC and to highlight mitigation efforts made by the private sector.
