Respectfully referred herein letter sent thru email dated January 24, 2022 bearing Reference Code No. **ACE-20220128-001**, coursed thru to the Head Executive Assistant, and further conveyed to the DENR Action Center/ Hotline from Mr. Elbert Reynoso <elbertreynoso2015@gmail.com> pertaining to his complaint against CENR Employee Mr. Rodney Verian of Tambis Road, San Jose, Puerto Princesa City, Palawan on the latter's alleged use of prohibited firecrackers (Judah's Belt) during New Year's celebration which caused uneasiness due to its emission of harmful chemicals – an act that is purportedly inappropriate for a DENR employee. Mr. Reynoso cited Republic Act no. 7183 and Executive Order no. 28 which stipulates detailed regulations and control on the use of firecrackers and other pyrotechnic devices in the country. In lined with this, a previous complaint was also filed last February 2021 against CENR Employee Verian who allegedly abandoned his renovation's leftover materials in front of his house which invaded the public road as well, causing hindrance to develop a rented parking space in the inner area. Hence, Mr. Reynoso is seeking for appropriate action, consistent with existing laws, rules and regulations to address this complaint.

Kindly inform directly the complainant of action taken in this regard furnishing the HEA and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.
