

**WHEREAS**, present DENR guidelines provides that fallen trees brought about by disasters or calamities shall be under the custody of Bgy. Government concerned, and cutting thereof requires authorization from DENR, Bgy. Government and Municipal Environment and Natural Resources Office (MENRO);

**WHEREAS**, San Vicente was among the municipalities severely hit by typhoon Odette which wreaked massive destructions and damages to residential houses, forest, agriculture, livelihoods, infrastructures and government facilities, among others;



**WHEREAS**, due to typhoon Odette, many trees had felled down in public and private areas which some had caused serious damages to residential houses and other public and private properties. These trees are good materials and can be utilized by the residents for repair or construction of their houses especially those whose shelters were totally downed by the typhoon;

**WHEREAS**, the temporary suspension of the collection of requirements for cutting of these trees will indeed ease the burdens of our people and likewise aid their recovery from serious effect of typhoon Odette through immediately providing them raw materials to rebuild or repair their houses;

**NOW, THEREFORE**, on motion of Councilor Antonio E. Rabina, Jr., duly seconded by all members present, be it


**RESOLVED**, as this body hereby resolved to request the Department of Environment and Natural Resources (DENR) thru Community Environment and Natural Resources Office (CENRO) and Provincial Environment and Natural Resources Office (PENRO) to temporarily suspend the requirements for the cutting of fallen trees due to typhoon Odette for its immediate use of the affected residents in the construction/repair of their houses.

**RESOLVED, FURTHER**, to request the Municipal Environment and Natural Resources Office to closely coordinate with the DENR, CENRO, PENRO and other concerned Agencies in relation to cutting of fallen trees, and likewise spearhead dissemination of any relevant measures and information to our local residents.


