

Respectfully referred herein letter sent thru email dated December 03, 2021, addressed to President Rodrigo Roa Duterte thru Dir. Jaime Llaguno Mabilin, Presidential Complaint Center (PCC) bearing Code No. **WG-NEM-11-06-2019-056**, transmitted to Secretary Roy A. Cimatu thru USEC Rodolfo C. Garcia, indorsed to the Head Executive Assistant, and further conveyed to the DENR Action Center/Hotline from 2Lt. Conrado B. Idia, PN (Ret.) of Sandoval, Bataraza, Palawan pertaining to his 33.36 sq m lot that was allegedly declared as part of the provincial road by Palawan Provincial Engr. Salito M. Purisima. Allegedly, the same lot runs from the national highway to the quarry site of the mining company Rio Tuba Nickel Mining Corporation, a total distance of 2.8 km. The complainant stated that the road was initially smaller but was widened in late 2000 by heavy equipment to serve as passageway for limestone-carrying dump trucks. 2Lt. Idia further claims that the said declaration bears no consultation, Waiver of Right, and Deed of Donation, thus, merits this letter of complaint for appropriate action, consistent with existing laws, rules and regulations.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC, HEA, and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.
