Greetings!

This is in connection with a concern Ms. Riza C. Perez lodged before [Complaint@8888.gov.ph](mailto:Complaint@8888.gov.ph) alleging the issuance of Tax Declaration to Mr. Paul Edison Rosales involving a tract of land near the Pamuyan Falls in Bgy. Port Barton, San Vicente, Palawan. Geographic returns gathered on site as identified by Ms. Perez before representatives of this Office disclosed that it is within the forest lands classified timber land, being within Block A of Land Classification Project Numbered 1-U which was approved on 29 June 1987 as LC Map No. 3309.

Entry and occupation thereof without any of the instruments the DENR may by discretion issue under Special Forest Land Use provisions of the law, including declaration thereof for purposes of tax collection, are prohibited specifically by Sections 78 and 84 of RA 7161 amending and renumbering certain provisions of PD No. 705, the Revised Forestry Code.

Appropriate action by the Assessors' Offices concerned is hereby enjoined should tax records affirm the foregoing issuance.

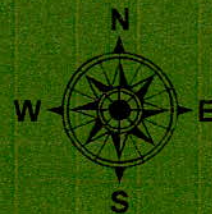
