Respectfully referred herein letter sent thru email dated 25 April 2022 addressed to President Rodrigo Roa Duterte thru Dir. Jaime Llaguno Mabilin, Presidential Complaint Center (PCC) bearing Code No. **PM-AKA-06-23-2022-040B**, transmitted to the Office of the DENR Secretary, indorsed to the Head Executive Assistant, and further conveyed to the DENR Action Center/Hotline from Ms. Dely Panol of Purok Magalang, Sampaloc St., Brgy. Sta. Monica, Puerto Princesa City, Palawan pertaining to her request to grant to their DFP Foundation the 118-hectare parcels of land in Brgy. Irawan, Puerto Princesa, Palawan which is under a Socialized Industrial Forest Management Agreement (SIFMA) and to help them to properly manage it. Accordingly, the subject lots were initially applied for survey by the then Irawan Brgy. Captain Benny Resuma, however, even after eight (8) years have lapsed, the area was still not distributed to its "rightful" proprietors - which resorted to their forceful occupancy. However, they were allegedly being harassed leading to the demolition of several houses and the fencing of the area. Due to recent demise of Brgy. Captain Resuma, Ms. Panol is seeking assistance to grant this request which she claimed will aid the landless locals in their area. Hence, this merits for your appropriate actions, consistent with existing laws, rules and regulations.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC, HEA, and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.


