



Resolution No. 021 Series of 2022

RESOLUTION REQUESTING THE HONORABLE GOVERNOR
EDUARDO B. GADIANO TO ALLOCATE FUNDS FOR THE
DREDGING OF TUBAONG AND PANDURUCAN RIVER

WHEREAS, Barangay San Roque in its geographical location is an island besides the San Jose Town Proper surrounded by bodies of water including Tubaong and Pandurucan River;

WHEREAS, Tubaong and Pandurucan River are two major outlets of the drainage system of the town proper of the Municipality of San Jose;

WHEREAS, at present Tubaong and Pandurucan River is already silted and the cause of flooding not only in Barangay San Roque but in other nearby Barangays, Barangay Bubog, Bagong Sikat, Poblacion 3 and Poblacion 4;

WHEREAS, as far as we know, Tubaong and Pandurucan River (two (2) of the biggest river in the Municipality of San Jose was not dredge for several years;

WHEREAS, dredging of these two (2) rivers will benefit a lot of residents of Barangay San Roque and other nearby Barangays;

NOW THEREFORE, upon motion of Kagawad Joselito A. Dinglasan, unanimously seconded by all the members, the Sangguniang Barangay of Barangay San Roque approved as it is hereby approved this resolution requesting the Honorable Governor Eduardo B. Gadiano to allocate funds for the dredging of Tubaong and Pandurucan River;

UNANIMOUSLY APPROVED during the Regular Session of the Sangguniang Barangay of Barangay San Roque, San Jose, Occidental Mindoro on July 11, 2022 at the Barangay Session Hall.
