- 1. Improve the understanding and appreciation of the importance of AHPs in the conservation of biodiversity in the ASEAN;
- 2. Assess the impact of COVID-19 pandemic in the Philippine ASEAN Heritage Parks;
- 3. Discuss and exchange experiences and practices on the management of AHPs;
- 4. Identify further activities to improve management of AHPs in the Philippines;
- 5. Promote partnership and networking among the AHPs in the Philippines; and
- 6. Prepare Philippine inputs to the 7th AHP Conference to be held on October 2022 in Indonesia
