This has reference to your email letter dated June 9, 2022, requesting this Office for the Geographically-Referenced Boundaries in GIS Vector file per Regional, Provincial, Municipal up to Barangay level in the Philippines.

In reply, we are providing you with a copy of the Masterlist of Land Area 2019 stored in a compact disc (CD) which was submitted to the Department of Budget and Management (DBM) on December 30, 2019. However, the said Masterlist of Land Area is still subject to the validation by the Technical Working Group (TWG) created under OCD Resolution No. 1 Series of 2005 dated 12 September 2005, which is composed of DILG, NAMRIA, and League of Cities, Municipalities, and Provinces. May we further inform you that the said Masterlist's data is composed of Uncontested and Contested Areas, and therefore, does not reflect the actual boundaries of the Local Government Units (LGU).

As such, please be informed that this Office has no data on the barangay boundaries, however, on even date we forwarded your request to our DENR Regional Offices for appropriate action.
