This refers to the email dated April 12, 2022 of Mr. Andres G. Badilla regarding status of his land problem/concern which was forwarded by the Presidential Complaint Center to this Office with Reference Code No. PCC-CAM-10-07-2021-216.

According to his attached undated letter, Andres G. Badilla filed a protest •n 2018 against Emily Lopez and Joseph Nepomuceno over six (6) hectares, more or less, parcel of land located at Magaleon, Sto. Niño, San Vicente, Palawan. On 2019, a preliminary conference was conducted at the CENR Office Roxas. Mr. Badilla also submitted his position paper on July 12, 2019. However, he received no response regarding the status of his protest.

Records show that a Memorandum dated February 28, 2022 was issued by this Office directing your Office to advise CENRO Roxas to conduct an in-depth investigation and ground verification, in coordination with all the parties concerned, to determine the veracity of the complaint. Also, to submit Completed Staff Work (CSW) with categorical recommendations within seven (7) working days upon receipt thereof.

In view of the above, may we request for an update regarding the pending protest of Mr. Badilla over Lot No. 3452, Cad 860-D situated in Magaleon, Sto. Niño, San Vicente, Palawan, and/or for the records of the subject case with final investigation report be forwarded to this Office for its resolution.

Please be reminded that failure to timely respond to the public's concern shall be a ground for administrative sanctions pursuant to the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018, and other existing laws and regulations.
