2. National Integrated Protected Area System Act (RA 7586)



On June 14, 2022, the Mt.Calavite Wildlife Sanctuary held a meeting at the Municipal Gymnasium of Paluan, Occidental Mindoro with sphere headed by Protected Area Superintendent Orlando R.Ramos. The consultation meetings conducted with the local communities inside the protected area highlighted the following agenda, to wit:

1. Indigenous People Right Acts (IPRA LAW 8371)

2. National Integrated Protected Area System Act (RA 7586)

3. Revised Forestry Code of the Philippines Section 68 of PD 705
