Please be informed that this Office has no record on the application for Forest Land Use Agreement for Tourism (FlagT) Purposes of Gerry Forsgate Memorial Swamp Corporation (GFMSC) in Sitio Cansulit, Brgy. Bonbon, Looc, Occidental Mindoro in spite of diligent efforts to look into. Accordingly, the aforementioned application was directly submitted to the Regional Office without informing CENRO-Sablayan.

On July 19, 2022, personnel of this office attended the Sangguniang Bayan (SB) Session of the Municipality of Looc. It was learned that there was no application for FlagT of Gerry Forsgate Memorial Swamp Corporation that was endorsed by the aforesaid SB. Likewise, the Barangay Chairman of Bonbon attested that said application has no endorsement from his Office and further emphasized that the area applied for FlagT located at Sitio Cansulit is vacant and open for investment.

Moreover, Gerry Forsgate Memorial Swamp Corporation (GFMSC) has not yet made any coordination and/or communication with this Office pertaining to the matter.
