Dear **Mr. Guerrero**,

This pertains to your email dated May 24, 2022, addressed to President Rodrigo Roa Duterte thru Dir. Jaime Llaguno Mabilin, Presidential Complaint Center (PCC) bearing Code No. PCC-CYR-05-24-2022-076 and forwarded to DENR Action Center/Hotline regarding your request to plant fruit trees and crops in the unused portion of the Busuanga Pasture Reserve (BPR).

Please be informed that based on the documents of the BPR Management Office, it was found that the requests of Mr. Jacob Guerrero as reiterated in the previous response by this Office, in a memorandum dated June 27, 2018, from the Director, Forest Management Bureau had denied the request to develop a portion of BPR as fruit tree plantation. The same was relayed to the you through a letter dated August 17, 2018.

Please be again reminded that the area subject of your request is within the BPR pursuant to the President Proclamation 1387 s. 1975 which withdrawn the area from "sale, settlement or any form of disposition, exploration or exploitation" regardless of land classification status. Thus, the original proclamation reserving the area for pasture purposes will always be the primordial consideration of this Office.

In view of the above circumstances, as indicated in the previous response of this Office, we regret to inform you that your request cannot be granted. Likewise, all similar request/s for use, utilization and/ or development of the area within BPR, other than pasture/ grazing, shall not be allowed in line with the existing proclamation.

For future actions of this Office regarding your subject area of concern, will conduct ground verification/ investigation to have clarification on the specific area you want to develop for the proposed fruit tree plantation for the Office to determine whether such area is not in conflict with the intents of the BPR was established which is for pasture purposes only. Further, will communicate and request you to submit legal documents regarding the subject area of your association in the above-mentioned address within the BPR.
