DATE : June 10, 2022

Please be informed that on June 6-10, 2022 the undersigned personnel of this office conducted evaluation and assessment of CSC issued to Pastora L. Brigildo bearing **CSC No. 423031038** with a total area of **0.7877** hectare located at So. Ilog, Barangay San Miguel, Linapacan, Palawan.

Hereunder are result of the evaluation and assessment, to wit:

1. Mr. Pastor L. Brigildo, was awarded a Certificate of Stewardship Contract(CSC) on September 19, 1997 still existing and it will be expire on September 20, 2022
2. The CSC area have development planted with forest tress, fruit bearing tress, and agricultural crops but the CS area got 68 points only equivalent to "Failed" however the CS holder was executed a waiver of rights waiving, transferring and renouncing all their rights over the land to a certain Cristy Flores which is a gross violation of existing rules and regulations and a sufficient ground for the cancellation of Stewardship Contract.

Section 10.9 of DENR Administrative Order No. 4 Series of 1991 or otherwise known as the Revised Regulations Governing the Integrated Social Forestry Program (ISFP) and Section 6.3 of DENR Memo Circular No. 21 Series of 1993 stated the responsibilities of the holder and grounds for cancellation/termination of CSC, to wit;

Section 10.9 of DAO No. 4 Series of 1991 Refrain from transferring or assigning their allocated land or any portion thereof without approval from the DENR Secretary or his authorized representative.

"Section 6.3 of DENR Memorandum Circular, Series of 1993 Transferring the Certificate of Stewardships to other person through sale"

In view of the above facts and findings of the inspection team, the aforementioned CSC is recommended for cancellation of Stewardship Contract.

Attached are duly accomplished CSC Evaluation and Assessment Form together with sketch map and geotagged pictures taken during the conduct of assessment.

Bounded on the North by Lot 21; on the East by Lot 20-A and Mangrove; on the South by Lot 19; and on the West by Public Land.

and registered with the DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES in accordance with existing rules and regulations.

As (a) forest land steward(s), PASTORA L. BRIGILDO commit(s) himself/herself/themselves to protecting and enhancing the ecology of the land specified in this contract and to joining with other stewards in the area in protecting and enhancing their natural resource base. In exchange for such a commitment, the steward(s) shall have the right to peaceful possession, cultivation and enjoyment of his/her/their forest landholding and the fruits thereof, the right to manage and work on the forest landholdings in accordance with appropriate forest land and farm methods and practices, and such other rights as may be granted or provided by laws, orders, letters of instruction, rules and regulations.

The steward(s) shall also faithfully comply with the obligations specified under the Stewardship Agreement hereto attached.


