Only those who will receive the notification from the DOE will be accepted as finalist for the EEE Awards 2022.

If you are considered as one of the shortlisted entries, the DOE will request for a full paper submission which will be based on the criteria that will be forwarded by the DOE later on. This shall become the basis for the final judging and determination of this year's EEE Awardees. You may refer to the attached documents for more information.
