Thank you for endorsing me to Engr. Iringan, I understand that ARD Tuddao had already assigned the case to her for action.

Dear Engr. Iringan,

Thank you for taking the time to speak with me earlier.

We just want to note that the former Regional Executive Director ("RED") Maria Lourdes G. Ferrer has already issued a Memorandum dated 05 July 2021 regarding the result of the RTK Survey. It was addressed to PENRO-Palawan (copy furnished CENRO-Roxas), instructing them to deploy a team to:

1. Reject patent applications for lot/s within the salvage zone;

2. Deploy a team to conduct delineation of the 20- and 40-meters easement under PD 1067 on the stretch of the beach; and

3. Issue a Notice to Vacate to owners of the structures found within the easement zone.

In our latest request letters, we are following up on these Orders from the office of the RED.

You mentioned earlier that Engr. Donna Belle E. Luengo submitted an incomplete report on the RTK Survey conducted last 19 February 2021. Hence, your office requests a 'Completed Staff Work' (CSW) from her, as you need details from this document to decide on further actions to our request. For clarity, our request is a follow up to the above-mentioned instructions of the RED. May we ask what you are clarifying and who asked for this clarifications?

Again, we would like to reiterate that the office of the RED, in view of the findings and recommendation of the Chief, Survey, and Mapping Division, has already issued an Action Order regarding the result of the RTK survey. Kindly refer to the attached file for your reference.

Finally, we understand that a new Memorandum addressed to PENRO Palawan (copy furnished CENRO-Roxas) is currently being prepared for dispatch. May we ask what this Memorandum is and upon whose initiative is this being drafted? We would like to respectfully ask your good office to pay regard to the previous memorandums, notices to vacate, and/or letters on taking action to our present follow up.

We would also like to request to furnish our office with a copy of the said Memorandum, once available.
