Respectfully referred herein letter sent thru email dated 23 May 2022, addressed to President Rodrigo Roa Duterte thru Dir. Jaime Llaguno Mabilin, Presidential Complaint Center (PCC) bearing Code No. **PCC-CYR-02-01-2022-081**, and indorsed to the DENR Action Center/Hotline from Mr. Agustin Saluague of Brgy. España, San Fernando, Romblon thru "Issah Saluague" <isaluague28@gmail.com> pertaining to the follow-up of his request on granting the 186-hectare Lot #1156 (considered as Alienable and Disposable Land) among the impoverished local people in their area. Accordingly, Mr. Saluague's ancestors had originally occupied and cultivated the area since 1950s, however, elected Vice Mayor Doming Marin allegedly covertly applied for its titling for which your Office affirmed on your letter dated 08 February 2022 addressed to the requesting party that the same was titled under Mr. Marin on 30 January 1987 after his "compliance of requirements set by the law". Due to this conflict of interests, Mr. Saluague is requesting for the investigation of the legal proprietorship of the subject lot which merits for your appropriate actions, consistent with existing laws, rules, and regulations. Please note that PENRO Romblon referred the matter to your Office following the letter dated 08 February 2022 addressed to the complainant.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.

This has reference with your concern lodged to Presidential Complaint Center (PCC) with bearing Code No. PCC-02-01-2022-081 reiterating the request to grant the 186-Has. Lot# 1156 among the local people of Barangay España, San Fernando, Romblon.

Please be informed that this Office had already referred your immediate concern to MIMAROPA Regional Office as well as to the Land Management Bureau for their further instruction dated 26 October 2021.

Likewise, under existing laws, rules and regulations in particular the Public Land Act (Commonwealth Act No.141) provides that the lands of public domain alienable or open to disposition shall be classified first according to the use or purposes through issuance of presidential proclamation duly published or by Act of Congress.

During phone calls with our 8888 Focal Person on 8 February 2022, this Office will take responsibility to collaborate with higher authorities and other concerned agencies as well as LGU's in initiating the said proclamation for the benefits of the people and taking consideration on the protection of remaining forested area found within Lot#1156.

With regard to Mr. "Doming" Marin, the area granted to him is Lot 1180 AD and identified as Public Land. The said lot is Titled under his real name Domingo Marin dated January 30, 1987 after compliance of requirements set by the law.

Moreover, please rest assured that we will continue to inform you about any updates pertaining to your primary concern.

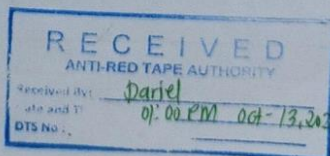

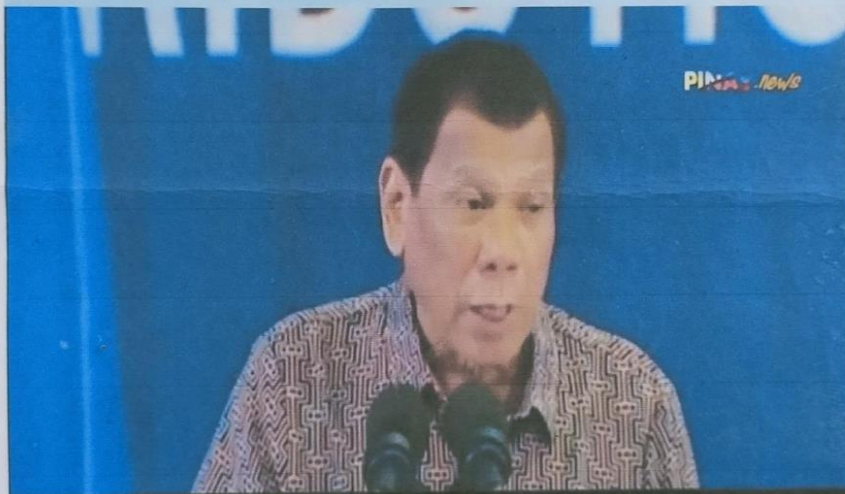

This is to acknowledge receipt of your letter to President Rodrigo Roa Duterte and referred to this office for immediate response/action accordingly.

BACKGROUND

Sometime in 1991 when the group of Adventist Farmers Association (SDAFA) of San Fernando, Romblon inquired regarding the status of Lot 1156. The association of SDAFA covering Lot No. 1156 Cad 477-D that lease application be rejected on the ground that these applications are mere dummies of the Seventh Day Adventist which is in violation of public land law and that recommended lot 1156 Cad 477-D be awarded to bonafide landless constituents of Brgy. Espana, San Fernando, Romblon.

On other hand, Lot 1156 was recommended for the project site in compliance with EO 114 known as BALIK PROBINSYA-BAGONG PAG-ASA (BP2) PROGRAM under the administration of President Rodrigo Roa Duterte.

Recently, the subject lot was recommended for the establishment of Economic Zone (ECOZONE) (See attached memorandum) of the province in Compliance with the letter request of Director General, Bgen. Charito Plaza, MNSA, Ph.D. of the Philippine Economic Zone Authority (PEZA).

ACTION TAKEN

- This office have already instructed Special Investigator Eric F. Hindap which is now in the vicinity to conduct an ocular inspection and to have a dialogue among stakeholders;




