SAID ACTIVITY SEEKS TO CREATE GREATER ACCOUNTABILITY AMONG FOREST TENURE HOLDERS AND IN TURN, WOULD MINIMIZE THE NEED FOR THE FIELD OFFICE IN CONDUCTING ANNUAL MONITORING TO INDIVIDUAL TENURE INSTRUMENT HOLDERS WITH REGARDS TO THEIR COMPLIANCE WITH THE AGREEMENT, LAWS, RULES, AND REGULATIONS.
