



The collecting officer shall also perform other duties inscribed in the PAMB Resolution No. 2019-015 Series of 2019.

This order takes effect immediately and shall remain enforce unless revoke by the undersigned or other higher authorities.

A RESOLUTION RECOMMENDING THE DESIGNATION OF ECOMS II REBECCA M. DELGADO AS SPECIAL COLLECTING OFFICER OF MT. GUITING-**GUITING NATURAL PARK**

WHEREAS, it is within the powers, duties and functions of the Protected Area Management Board (PAMB) to approve policies, guidelines, plans and programs, proposals, agreements and other related documents, including the Manual of Operation for the efficient and effective management of Mt. Guiting-Guiting Natural Park (MGGNP);

WHEREAS, Section 16 of the Republic Act 7586, otherwise known as the National Integrated Protected Areas System (NIPAS) Act of 1992, and Rule 18.7 of its Revised Implementing Rules and Regulations (DAO 2018-26) provides the designation of a Special Collecting Officer (SCO) for each protected area;

WHEREAS, EcoMS II Rebecca M. Delgado is designated SCO and shall perform the following functions:

- Collects and receives pertinent sees, charges, donations, and all other income for ML Guiting-Guiting Natural Park, e.g. entrance fees, resource user fees, and other fes collected and derived from the operations of the Park;
- Deposits/ remits the collections under the IPAF Trust Fund at any Government Servicing Bank accessible to the area;
- Submit quarterly reports of collections to the PAMB (using the prescribed format) which shall in turn to be submitted to the Regional Executive Director (RED) through the Protected Areas, Wildlife and Coastal Zone Management Service (PAWCZMS) and Protected Areas and Wildlife Bureau (PAWB);
- Maintains book of accounts and records;
- Prepare and submit Work and Financial Plan and other requirements as basis for disbursement'
- Maintains records/documentation of all expenditures, voucher s, receipts etc., and
- Prepares reports of expenditures based on approved Work and Financial Plan;



WHEREFORE, premises considered after due deliberation and upon motion of Hon. Maryjane R. Rocero, duly seconded by Hon. Joven R. Rodeo and approved by majority members of the PAMB of Mt. Guiting-Guiting Natural Park; be it

RESOLVE, as it is hereby resolve Recommending the Designation of EcoMS II Rebecca M. Delgado as Special Collecting Officer of Mt. Guiting-Guiting Natural Park:
