BARANGAY CERTIFICATION IN PROCESSING OF PUBLIC

LAND APPLICATIONS (PLAS)

This is in reference to **notarized Barangay Certification** required in DENR Memorandum Circular (DMC) No. 2019-10 under Section 4.2 processing of requests for Survey Authority/Order and 4.4 processing and approval of PLAs.

Be informed that this is the common delays in the process because the Barangay Certification being submitted is not notarized. When asked to comply with the applicants, often reasons, they still need to bring and present the Barangay Chairperson before the Lawyer or Notary Public in order to notarize the certification; which causes inconvenience to them and to the barangays.

In lieu of this, the undersigned respectfully requesting for consideration of unnotarized Barangay Certifications, being public document that must be given full faith and credence. The Barangay Chairperson as public officer will not certify the identity of the applicant for public land if he/she does not know in his/her official capacity that the applicant is the actual occupant; and in support to what is stated in Barangay Certification is the Affidavits of two (2) disinterested person duly sworn by public land inspector/investigators of the Office.
