II. Background

A. This is with reference to the endorsement of the Presidential Proclamations declaring the EKPLS and PIPLS in 2019. The Office of the Deputy Executive



Secretary for General Administration of the Office of the President (OP ODESGA), has recently followed up on the following:

- 1. the signature of the Maps, with technical descriptions, of the EKPLS and PIPLS by BMB and NAMRIA Officials to ascertain their correctness;
- 2. conduct, or preparation, of (a) a protected area occupants survey; (b) an ethnographic study; (c) a protected area resource profile; (d) land and water use plans; and (e) other background studies, in compliance with Section 4(c) of the Expanded NIPAS Act;
- 3. results of public consultations; and
- B. The Protected Area Suitability Assessment (PASA) can be undertaken to address most of the clarifications in Item d.i. above, supplemented by the scientific reports of DENR BMB Projects with the University of the Philippines on the West Philippine Sea, namely PROTECT WPS and PROTECT WPS 2.0.
- C. The conduct of PASA Forms 1 and 2 (item D.3. above) have already been partially completed (around 75%) by BMB Staff during the recently concluded BMB meeting-workshop, and the Pag-asa Islands Expedition, community consultations, and Key Informant Interviews. However, some of the relevant information and reports may be housed in PENRO Palawan, CENRO Puerto Princesa, Palawan Council for Sustainable Development and its Staff (PCSDS) or other Offices of the Local Government Unit of the Municipality of Kalayaan.

III. Recommendations:

Foregoing considered, may we coordinate with your Offices for your availability to accommodate BMB Focal Staff to complete the PASA Forms on June 9-10, 2022, in Puerto Princesa City, Palawan. Upon completion, the PENRO Palawan and RED may also affix their signatures onto the Forms.
