Good day!

The Department of Agriculture—Philippine Rural Development Project (DA-PRDP) MIMAROPA sought to formalize the commitment of the agencies by institutionalizing a formal convergence that ensures the participation of relevant regional line agencies of the government that will harmonize, mainstream, and ensure that the priority investments included in the Provincial Commodity Investment Plans (PCIPs) are properly funded, implemented, and supported. The PCIP is a strategic plan that rationalizes the interventions within the various segments of the value chain of the prioritized commodities of MIMAROPA provinces.

In the context of PCIP implementation, the major non-PRDP support is generated through the interagency convergence initiative composed mostly of relevant national government agencies. However, these agencies' functions and PAPs are affected by the Mandanas-Garcia Ruling, while the LGUs now bear more responsibilities corresponding to the resources that will be devolved to them.

It is imperative at this point to see and appreciate the ongoing efforts of NGAs and LGUs during this transition year.
