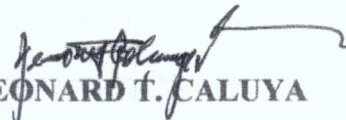
SUBJECT : **COMMITMENT TO SUPPORT DENR EMPLOYEES OF CENRO

- In the event that anyone will retire from service in DENR, CENRO Quezon, Palawan, each co-employee will contribute an amount equivalent to 2% of their basic salary;
- In case of sickness and death; contribution amounting to P500.00 for Salary Grade 15 (SG) and above and P300.00 for Salary Grade 14 (SG) and below will be collected to all CENRO Quezon employees. Said amount are allotted for:

b.1. Sick employee who is hospitalized and undergo minor and major operation with five (5) days confinement in hospital;

b.2. Deceased employee; through his/her immediate family member; and

b.3. employees whose immediate family member had passed away, (father, mother and children).

That all signatories of this covenant will voluntarily give their contributions to Planning Officer Forester II Janes Panes five (5) days prior to the scheduled retirement ceremony and mourning activity on the aforementioned beneficiaries.

That, the newly hired and assigned personnel of DENR, CENRO Quezon, Palawan will be inevitably covered by this agreement/covenant.

That we, the herein signatories, do hereby bind and honor this will and covenant and that we executed this Deed of Agreement out of our own free will and volition never been forced nor intimidated.
