De Lara <joel_sailor@yahoo.com> pertaining to his follow-up request for the results of the ground verification survey dated 28 January 2022 conducted by Engr. Mary Dominique B. Lavadia over Lot Nos. 446 and 449, PLS-26 situated at Sitio Tinangra, Brgy. Tubili, Paluan, Occidental Mindoro. On their letter attached herein dated 08 April 2022, addressed to the requesting party, PENRO Occidental Mindoro states that the said results were already transmitted to your Office for evaluation and confirmation of the Surveys and Mapping Division. Such results are significant since the former mayor of the area under the name Sherly Pangilinan allegedly instructed the fencing of the lots in question, thereby prohibiting the requesting party to continue their farming activities. Hence, this merits for your appropriate actions, consistent with existing laws, rules and regulations.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority.
