In the spirit of integrity and honesty, our continued efforts to fight graft and corruption has been significantly escalated through the initiative of the Presidential Anti-Corruption Commission (PACC). To formally commence the agreement of the PACC and DENR, the agency has launched the DENR's Committee on Anti-Corruption (CAC) on February 15, 2022

via Zoom in the presence and participation of the Undersecretaries, Assistant Secretaries, Service Directors, Regional Offices, Bureaus, Attached Agencies, PENROs and CENROs.

Pertinent to the aforementioned agreement, the Legal Affairs Service and the CAC crafted two Daily Incident Report (DIR) Templates derived from the Pro Forma Report of the PACC in pursuant to the 24-hour reporting requirement of Commission. As discussed in the recent Launching, the two templates shall be used for reporting corruption-related complaints and updates on cases under preliminary investigation to be addressed to the Commission.
