SUBJECT : RECONSTITUTION OF MINE REHABILITATION FUND COMMITTEE FOR IPILAN NICKEL CORPORATION

In the interest of the service and to effectively implement the environmental provisions of DENR Administrative Order (DAO) No. 2010 – 21, the Revised Implementing Rules and Regulations of Republic Act No. 7942, otherwise known as, the "Philippine Mining Act of 1995," the Mine Rehabilitation Fund Committee (MRFC) for the Ipilan Nickel Project of Ipilan Nickel Corporation (INC) is hereby created.

Pursuant to Section 183 of the said DAO, the MRFC shall be composed of the following:

1. MGB MIMAROPA Regional Director as Chairperson;
2. DENR MIMAROPA Regional Executive Director as Co-Chairperson;
3. EMB MIMAROPA Regional Director as Member;
4. NCIP MIMAROPA Regional Director as Member;
5. PCSDS Executive Director as Member;
6. Governor of Palawan as Member;
7. Mayor of the Municipality of Brooke's Point as Member;
8. Representative from Haribon Palawan as Member;
9. Representative from Apostolic Vicariate of Puerto Princesa City as Member;
- and
10. Representative from Ipilan Nickel Corporation as Member.

The Committee shall perform its duties and assume the responsibilities stipulated in Sections 182 and 184 of DAO No. 2010 – 21.

This Order shall take effect immediately and shall remain in force, unless otherwise revoke by the undersigned or higher authorities.
