During the 29th Meeting of the Inter-Agency Task Force for the Unified Implementation and Monitoring of Rehabilitation and Recovery Projects and Programs in the Yolanda Corridor (IATF-Yolanda) held on 16 February 2022 via online meeting, the Chairman directed the Department of Environment and Natural Resources (DENR) to accomplish the following:

- Expedite the release of the investigation report involving the land titles of the Yolanda Permanent Housing Program (YPHP) sites located within the Busuanga Pasture Reserve in Coron, Palawan;
- 2. Assist the NHA in identifying alternative sites for the YPHP in Palawan, should existing sites prove to be unsuitable; and
- 3. Assist the IATF-Yolanda PMO in coordinating with relevant agencies and experts in order to resolve the pending issues of the YPHP in Palawan.
