SUBJECT : **REQUEST FOR PARTICIPANTS TO THE TARGETING
REGIONAL INVESTIGATIONS FOR POLICING
OPPORTUNITIES AND DEVELOPMENT (TRIPOD) PROJECT'S
COUNTER TRANSNATIONAL ORGANIZED CRIME (CTOC)
TRAINING**

The World Wildlife Fund (WWF) is executing the Targeting Regional Investigations for Policing Opportunities and Development (TRIPOD) Project, a Bureau of International Narcotics and Law Enforcement Affairs (INL)-funded, with Freeland Foundation, a Thailand-based Non-Governmental Organization (NGO), as the primary holder of the project. This initiative is being supported by the DENR-Biodiversity Management Bureau.

The Project aims to combat wildlife trafficking in selected regions, namely: Malaysia, Indonesia, and Philippines through a) improving counter wildlife trafficking enforcement; b) reduce wildlife trafficking in target areas; and c) enhance care and repatriation of confiscated animals. The abovementioned regions were specifically targeted due to its high wildlife biodiversity, used as wildlife transit points, and high numbers of seized cases. As part of the strategy to combat wildlife trafficking in the Philippines, the Project will conduct Counter Transnational Organized Crime (CTOC) training with the following schedule:

- Online CTOC training (90+ pax for Ind, Malaysia, and Philippines; in June)
- CTOC face to face training (25 pax; PH- August end)
- National OTJ and SIG working group (4-5 pax; PH = September)
- Regional Workshop (CTOC OTJ exercise, SoP development, draft for Indonesia and Malaysia, marine turtle genetics training; in Indonesia = October)

The CTOC training will convene and train law enforcement and other government agencies to form enforcement chains that can identify and disrupt transnational organized crime groups involved in transnational trafficking. This aims to help enforcement officers move beyond seizures and low level arrests to identifying, weakening and ultimately dismantling cross-border illicit supply chains that are decimating populations of wild flora and fauna.

We have initially identified the following personnel (see attached list) from your office/agency as possible participants in the training but we welcome your recommendation for additional possible participants who have a background and experience on wildlife law enforcement. Attached herewith is the registration and Leahy Vetting form for the possible training participants. Due to the requirements of the project and its funder as well as the need for the issuance of special orders on the part of government agencies, we need to have the training participants identified as early as possible.

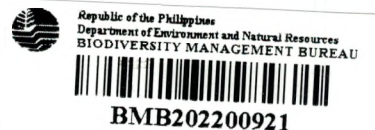
A staff from our partner organization, Tanggol Kalikasan will coordinate with your Office to get confirmation of your participation, as well as the names of your representatives.
