Respectfully referred herein email dated March 15, 2022, addressed to President Rodrigo Roa Duterte thru Dir. Jaime Llaguno Mabilin, Presidential Complaint Center (PCC) bearing Code No. PCC-CYR-02-01-2022-081 and conveyed to the DENR Action Center/Hotline from Mr. Agustin Saluague of Brgy. Espana, San Fernando, Romblon pertaining to the follow-up on his letter requests dated 8 October 2021 and 01 February 2022 on granting them back the 150-hectare Lot #1180 (considered as Alienable and Disposable Land) among the impoverished local people in their area. Mr. Saluague claims that the subject lot was allegedly encroached by Mr. Doming Marin - the father of the Chief Officer of the Department of Agrarian Reform (DAR) in their municipality - for whom a land title was purportedly issued. However, the requesting party claims that he and his predecessors were the original claimants of the subject lot where proof of cultivated area consisting of matured planted coconut trees can be observed. Please note that we previously referred this concern to your office dated 07 February 2022 under the same PCC code number and that Mr. Saluague affirmed that this concern has been referred to your office previously thru the Anti-Red Tape Authority (ARTA) Office and thru DENR Region IVB Regional Office, hence, may we request for your submission of final report relative hereof, consistent with existing laws, rules and regulations, as basis for closure/fully acted.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.



Greetings!

This is to acknowledge receipt of your letter to President Rodrigo Roa Duterte and referred to this office for immediate response/action accordingly.

### BACKGROUND

Sometime in 1991 when the group of Adventist Farmers Association (SDAFA) of San Fernando, Romblon inquired regarding the status of Lot 1156. The association of SDAFA covering Lot No, 1156 Cad 477-D that lease application be rejected on the ground that these applications are mere dummies of the Seventh Day Adventist which is in violation of public land law and that recommended lot 1156 Cad 477-D be awarded to bonafide landless constituents of Brgy Espana, San Fernando, Romblon.

On other hand, Lot 1156 was recommended for the project site in compliance with EO 114 known as BALIK PROBINSYA-BAGONG PAG-ASA (BP2) PROGRAM under the administration of President Rodrigo Roa Duterte.


### ACTION TAKEN


